SERVICES INCLUDED INTENSIVE CASE MANAGEMENT; HUD CERTIFIED HOUSING COUNSELING, FAMILY WELLNESS, DOMESTIC VIOLENCE AND YOUTH ENRICHMENT PROGRAMS. THE LENGTH OF STAY IN AN NH EMERGENCY FAMILY SHELTER IS 41% LESS THAN THE CITYWIDE SHELTER SYSTEM. SHELTER UNITS ARE LOCATED IN THE LOWER EAST SIDE OF NYC AND IN THE BELMONT AREA OF THE BRONX. IN FY 16 NH ACHIEVED A 141% OF GOAL IN PLACING HOMELESS FAMILIES INTO PERMANENT, SAFE HOUSING.

IN FY 16 OUR NEW YORK STATE SUPPORTIVE HOUSING PROGRAM CONTRACT EXTENDED TO INCLUDE UNITS IN BOTH THE BRONX AND THE LOWER EAST SIDE. OF THE 60 HOUSEHOLDS IN SUPPORTIVE HOUSING, ALL HAVE REMAINED STABLY HOUSED. TWO HAVE MOVED FROM SUPPORTIVE TO MARKET HOUSING, ONE FAMILY NOW OWNS ITS OWN HOME THROUGH A NEW HOME INITIATIVE FOR WORKING FAMILIES.
